TERMS OF AUCTION

1. Open auction participation fee is Rs. 2000/- (Non-refundable)

7. All Government Taxes Levis Charges duties etc if any shall be borne by the buyers as per section 236/A advance tax @ 10% of the gross sale price will be collected from the bidders
