TENDER NOTICE FOR HEALTH INSURANCE

The Sindh Agriculture University, Tandojam invites Single Stage – Two Envelope sealed bids under SPPRA Rules 2010 (amended 2013) for providing Health Insurance Services to its employees and their dependent family members from Insurance Companies having minimum 5-years' experience in rendering similar services.

(2) **Duration:** The contract period shall be 12-months and extendable further for 1-year more as per ToRs of agreement.

(3) **Eligibility:** The Company must be approved with SECP, SRB and registered with GST & Income Tax authorities.

(4) **Method of Procurement:** The University would adopt single stage – two envelope procedure for selection of firm. The bidder should submit Two-Separate sealed envelopes, containing the technical proposal and the financial proposal. Both envelope(s) should be marked “**Technical Proposal**” & “**Financial Proposal**” showing tender inquiry number.

(5) **Bidding Tender Documents:** Tender documents with detailed specification can be obtained from the office of undersigned against the paid challan/Demand Draft/Pay Order of Rs.2000/- (Non-refundable) or can be downloaded from www.pprasindh.gov.pk / www.sau.edu.pk.
