VACANCY ANNOUCEMENT

Sindh Agriculture University Tandojam needs following 'faculty/ non faculty staff' for project titled 'Establishment of SAU, Campus at Umerkot' being funded by the Government of Pakistan through PSDP of the Higher Education Commission (HEC), Islamabad. All the positions are purely on contract basis, initially for a period of one (01) year and extendable further up-to completion of the project, provided extension will be made on the satisfactory performance. In this context, applications are invited on prescribed Application Form, from eligible candidates, having domicile of Sindh Province possessing required qualifications, experience, skills etc as mentioned against each.



Lecturer (BPS-18) English	First class Master/ MPhil/ equivalent degree awarded after 18 years of education in the relevant field from HEC recognized University/ Institution with no 3 rd division in the academic career. Condition of no 3 rd division shall not be applicable provided that the candidate holds a higher degree viz PhD in the relevant field with not more than one 3 rd division in entire academic career. Age limit: 28 years up to closing date.
2.	Lecturer (BPS-18) Pakistan Studies	First class Master/ MPhil/ equivalent degree awarded after 18 years of education in Pakistan Studies/ International Relations/ Political Science from HEC recognized University/ Institution with no 3 rd division in the academic career. Condition of no 3 rd division shall not be applicable provided that the candidate holds a higher degree viz PhD in the relevant field with not more than one 3 rd division in entire academic career. Age limit: 28 years up to closing date.
3.	Lecturer (BPS-18) Software Engineering	First class Master's degree in Software Engineering from HEC recognized University/ Institution with no 3 rd division in the academic career. Note: Pakistan Engineering Council (PEC) valid registration is mandatory requirement. Age limit: 28 years up to closing date.
4.	Instructor (BPS-17) (Livestock Assistant)	First class DVM or equivalent degree in the relevant field from HEC recognized University/ Institution. Candidate(s) having 1 st class M. Phil in Livestock Management will be preferred. Note: Pakistan Veterinary Medical Council (PVMC) valid registration is mandatory requirement. Age limit: 28 years up to closing date.

5.	Photographer (BPS-11)	Intermediate from a recognized Board of Education with at-least three years experience in the field of shooting, processing of films and photography. Age limit: 28 years up to closing date.

Important Instructions:

1. Candidates applying for above posts need to submit two (02) copies of prescribed Application Form along-with attested photocopies of testimonials, photographs and domicile certificate, CVs with each set.
2. The application form can be downloaded from SAU Website; www.sau.edu.pk/jobs and must be submitted along-with application processing fee(non-refundable) of **Rs.3000/-** (Rupees three thousand) for all positions in BPS-17 and above and **Rs.1000/-** (Rupees one thousand) for Photographer through Challan in National Bank of Pakistan, Umerkot branch Account No.4149786718 or Demand Draft payable in favor of Director, SAU sub-campus at Umerkot.
3. Candidates applying for more than one position should submit separate application form for each post along with separate application form fee.
4. The candidates who are already in service in Government or autonomous bodies should apply through proper channel. They can submit advance copy of application form but shall have to produce departmental permission/ NOC at the time of written test/ interview otherwise their candidature may be rejected.
5. Application on plain paper and/or received after due date will not be considered.
6. Age relaxation will be admissible as per government rules.
7. The University reserves the right not to fill any post/ withhold the appointment against any advertised post.
8. Short listing of the candidates shall be made in accordance with the procedure laid down by the University. Only shortlisted candidates shall be called for test/interview and not eligible candidates will not be informed.
9. The decision of the University shall remain binding in all cases.
10. No TA/DA will be admissible for appearing at the interview/ written test.
11. Applications should be submitted to Assistant Director at SAU campus Umerkot .The last date for receiving application form is **21-11-2022** (no extra time will be allowed for postal transit delays etc. Candidates are expected to dispatch/ submit applications ahead in time)
