4. The candidates who are already in service in Government or autonomous bodies should apply through proper channel. They can submit advance copy of application form but shall have to produce departmental permission/ NOC at the time of test/ interview otherwise their candidature may be rejected.

6. Age relaxation upto **five (05) years** in the upper age limit beyond the maximum age limit as mentioned above will be applicable as per government of Sindh rules.
7. The University reserves the right not to fill any post/ withhold the appointment against any advertised post.
8. Short listing of the candidates shall be made in accordance with the procedure laid down by the University. Only shortlisted candidates shall be called for test/interview and not eligible candidates will not be informed.

10. No TA/DA will be admissible for appearing at the interview/ written test.
